- Ambition, Aspire, Achieve has agreed policies and supporting procedures in Child Safeguarding, Equalities, Sustainability, Health and Safety, Financial Control.
- All Ambition, Aspire, Achieve service delivery is underpinned by full procedures and guidelines and subject to full risk assessments.
- All Ambition, Aspire, Achieve trustees, staff and volunteers are subject to Disclosure Barring Service (DBS) checks at an enhanced level.
- All Ambition, Aspire, Achieve trustees give their time voluntarily and receive no remuneration or other benefits.
- Ambition, Aspire, Achieve employs staff supported by volunteers to deliver all our services. A hierarchy management structure is utilised.
- Ambition, Aspire, Achieve aims to work in partnership with other agencies and organisations wherever appropriate.

Objectives

- To advance in life, relieve needs of and help young people through
 - a. The provision of recreational and leisure time activities provided in the interest of social welfare, designed to improve conditions of life;
 - b. Providing support and activities which develop their skills, capacities and



capabilities to enable them to participate in society as mature and responsible individuals.

- To help young people, especially but not exclusively through leisure time activities, so as to develop their capabilities that they grow to full maturity a individuals and members of society.
- To act as a resource for young people up to the age of 23 living in East London (Barking and Dagenham, Hackney, Haringey, Havering, Newham, Redbridge, Tower Hamlets, Waltham Forest) and West Essex but providing advice and assistance ad organising programmes of physical, educational and other activities as a means of:
 - a. advancing in life and helping young people by developing their skills, capacities and capabilities to enable them to participate in society as independent, mature and responsible individuals;
 - b. advancing education;
 - c. relieving unemployment;
 - d. providing recreational and leisure time activity on the interest of social welfare for people living in the area of benefit who have need by reason of their youth, age, infirmity or disability, poverty or social and economic circumstances with a view to improving the conditions of life of such persons.

Summary of the main activities undertaken for the public benefit in relation to Ambition, Aspire, Achieves objectives:

- In planning our activities for the year, we have at all ties kept in mind the Charity Commission guidance on public benefit at our Trustee meetings.
- The core focus of all our activities remains working with young people who are disadvantaged, vulnerable and/or at risk due to their personal and family situations.
- We welcome all young people regardless of personal background, faith, gender, ability, disability or personal circumstances.
- We provide programmes and activities that raise each individuals personal confidence to have Ambition, the personal esteem to Aspire and the skills required to Achieve.



Summary of main achievements of Ambition, Aspire, Achieve between 23rd June 16 and 31st March 2017

- The establishment development of Ambition, Aspire, Achieve from just an idea to an
 active viable organisation, delivering qualitative work that is making a positive
 - sustainable difference for vulnerable, at risk and/or disadvantaged young people has been our major achievement across the year.
- AAA have secured our first base The Terrence Brown Arc in the Park, which provides:
 - A neighbourhood play and youth work hub for the North Canning Town area - which is in the top 3% of deprived wards in England.
 - ii. A Newham wide delivery and resource base for children and young people with a disability, additional need and/or life limiting condition.
 - iii. A base for Ambition, Aspire, Achieve located centrally in our East London catchment area.
- AAA provided over 100 activity based camping experiences for young people at risk including a rolling Summer camp at Outdoors Essex on Mersea Island, Essex.
- A group of 10 young people including 5 with a disability who were supported by their non-disabled peers, participated in a 6-day voyage on a tall ship sailing around the coast from Southampton to Tower Bridge London.
- In partnership with Waltham Forest Community Transport we provided over 300 Big Days Out for disadvantaged children who had no other opportunity of a day out to the coast. Each child enjoyed a free day at Southend including a visit to the Sea Life Centre, an afternoon enjoying all the rides in the Adventure Island Theme Park and refreshment throughout the day.
- We have successfully provided commissioned activities for the London Borough of Newham throughout the period focused on children and young people with disabilities and/or additional need. 40 young people participate each week and over 90 different young people have received a service.
- Each month we have delivered extremely popular:
 - i. Disco Nights for young people with needs and/or disabilities between 13 and 18 on the forth Friday of the month, which regularly engages 40 young people.



- ii. Family Fun Days for families with a disabled child(ren) on the forth Sunday of the month, benefiting over 45 different families during the year at the Terrence Brown Arc.
- We ran a very successful Easter Egg Appeal which raised over 750 eggs which are distributed to families in need, enabling the children to have an egg on Easter day this year. Something that so many take for granted.
- We have run 3 very successful inclusive doorstep sports clubs throughout the year after school and at weekends, engaging young people 8 and over in a wide variety of multi-sports for fun, personal skill development and/or competitions.
- We have facilitated a very successful education programme for young people with disabilities who have been permanently excluded from mainstream education due to their behavioural needs. Our programme offers a combination of life and core skills bridging the gap until a new permanent school is found for each young person.
- We have established a rolling programme of groups focused on young people considered to be at risk due to their personal and/or family situation, focused on offering structured opportunities that enable each young person to address and overcome the difficulties and issues they face.

Financial Review

Reserves Policy

Trustees have an agreed reserves policy, which is reviewed annually.

Ambition, Aspire, Achieve requires unrestricted reserved to safeguard the organisation and to cover situations such as fluctuations in receipt of payments and unforeseen events or situations that may happen.

Our current policy is to maintain an unrestricted reserve of £10,000 which we believe to be an appropriate level to cover our current level of operation and commitment.

We are aiming to increase the level of unrestricted resources, as Ambition, Aspire, Achieve develops and expands. Our current targets are:

£25,000 by the end of year 2

£50,000 by end of year 3

Ambition, Aspire, Achieve has £12,002 in unrestricted revenue at the period end.



Further Financial Details

During our first year Ambition, Aspire, Achieve has built a strong funding foundation on which we can build in the future.

Our funding policy is multi-faceted seeking funding from the following sources:

i. Charitable Trusts and Foundations

ii. National and Local Businesses

iii. Government and Other Statutory Sources

iv. Self/Community Fundraising

During the year we have established ongoing positive partnerships with a number of funders/supporters across all target areas.

We are particularly indebted to a number of individual supporters whose contributions have enabled AAA to experience such a successful and positive year. As we look to the future, AAA has a track record of qualitative delivery and successful outcomes which make a positive and sustained difference for the participating young people that we can demonstrate to potential new supporters and funders.

Similarly, we are indebted to Vincent Hayes at the Brick Lane Music Hall for enabling AAA to establish an annual benefit night that raises unreserved income that we can direct to innovative new work, reaching out to and making a different for vulnerable and at risk young people.
